Training for crisis situations

Exercises are crucial to help facilities, communities and governments prepare for unforeseen disasters of any kind. One of the keys to successful preparedness and response is well-trained leaders equipped with the proper tools to minimize adverse impacts during crisis situations. Training executive staff to respond properly to a situation that activates emergency plans is essential to successfully weathering an incident.

Program Overview

In April, 2023, the Los Angeles World Airports (LAWA), the City of Los Angeles, and other federal partners, participated in a hybrid workshop tabletop exercise facilitated by Tidal Basin Government Consulting (Tidal Basin) preparedness experts. LAWA required a consultant to create an exercise addressing multiple scenarios focused on intentional acts designed to cause harm to the airport, personnel, and passengers.

The exercise was held at the LAWA Police Facility Community Room with a team of participants called the Crisis Leadership Team (CLT). This group included 33 players, 10 observers, and nine exercise staff and partners from the following organizations:

- LAWA: executives and supervisors
- City partners: Los Angeles Fire Department, the Mayor's Office, Los Angeles Emergency
 Management Department
- **Federal partners:** Transportation Security Administration (TSA), Federal Aviation Administration (FAA), Customs and Border Protection, Center for Disease Control and Prevention (CDC)

Tidal Basin conducted an exercise that was divided into three modules, with each module focused on a different objective to ensure proper retention and understanding of the exercise outcomes. These modules were designed to be interactive and unique, with elements expanding beyond a standard tabletop exercise (TTX). The selected CLT members were expected to have a general familiarity with the day-to-day roles and functions of participating agencies. Tidal Basin stressed that each department or agency was a critical component to the exercise since each of them enable LAWA to cope with and respond to unforeseen emergencies.

The Challenge

The Solution

Customized Exercise Modules

Module One

The first module included a brief overview of the current LAX Emergency Operations Plan (EOP) and the CLT roles and responsibilities. We developed interactive polling questions to solicit anonymous feedback from participants.

Module Two

Module two focused on communication between the CLT members. After randomly assigning groups, participants were encouraged to engage with the scenario and each other with various communication limitations, simulating real-world communication barriers.

Participants were then provided information on an emergency scenario in four different simulated platforms with varying delays from the start of the incident. Communication platforms included one phone call, one text, an email, and social media posts. Conflicting information and misinformation were intentionally provided as well. The objective was for every CLT member to be notified of the incident, share information, and coordinate physically in one location for a simulated conference call.

Module Three

Tidal Basin's third module concentrated on decision-making during an emergency. Five stations were set up, each with a different scenario. Seven to 10 index cards were provided containing decisions that should be made to address an incident. Participants were allowed to ask questions for Essential Elements of Information (EEI) to facilitators, to which the facilitator provided updated information regarding the questions to assist their decision-making process.

Participants rotated through each station identifying critical decision points as indicated by the scenario and EEIs. Each group was encouraged to discuss their reasoning behind decision making, which command and control element was responsible for the decision (CLT, incident command, or incident support), and any gaps that could be closed with identifying different decisions to be made during the scenario-specific exercise.

Resilience Delivered

Tidal Basin's strong hands-on experience in performing work for a range of airports, local and federal critical infrastructure and transportation agencies, and California municipalities contributed to a successful workshop and exercise program for LAWA. The inclusion of leadership stakeholders made it a unique process.
